MOTION FOR RELIEF FROM THE AUTOMATIC STAY

COMES NOW Calvin Claimant and, pursuant to Rule 4001 and Rule 9014 of the Federal Rules of Bankruptcy Procedure and SC LBR 4001-1, moves this Court to grant Calvin Claimant relief from the automatic stay provisions of 11 U.S.C. §362 (the "Automatic Stay"). The movant would show this Court the following:

1. An Order for Relief under 11 U.S.C. Chapter 13 was entered on a petition filed by the above-named Debtor on Month Day, Year, and Trustee \_\_\_\_\_, Esquire, was subsequently named Trustee in said Chapter 13 (or 7 or 11) bankruptcy proceedings.

2. Claimant was/is employed by the Debtor and suffered an injury by accident which is compensable and covered by the SC Workers Compensation Act.

3. The Debtor has a workers compensation insurance policy with \_\_\_\_\_ company to pay the claim and cover the cost of defense.

4. The Debtor would further show that his recovery should be limited to the insurance proceeds and would therefore not diminish the assets of the estate nor be an administrative burden.

WHEREFORE, Calvin Claimant prays that:

(i) Pursuant to 11 U.S.C. §362(d), this Court grant relief from the provisions of the Automatic Stay, the provisions of 11 U.S.C. §524 (the stays effective upon discharge) and any and all other stays or injunctions which are or may be in effect, by terminating, annulling, modifying or conditioning said stays or injunctions as the insurance proceeds, so as to permit Calvin Claimant to exercise any and all remedies available to him under any applicable law or contractual agreement between Calvin Claimant and Debtor, including without limitation, the right to implement or continue proceedings before the South Carolina Workers' Compensation Commission;

(ii) Calvin Claimant be authorized to immediately enforce and collect any award or settlement from the insurance proceeds only it is awarded pursuant hereto; and

(iii) For such other and further relief as may be just, equitable and proper.
